PROCEDURES FOR OBTAINING OR RENEWING A NEVADA ANTIQUITIES PERMIT

Nevada Revised Statutes (381.195 – 381.227) outline authority and procedures for a Nevada Antiquities permit. The Nevada State Museum director issues state permits to conduct archaeological or paleontological investigations on state and federally managed public lands. **Please note** that a federal antiquities (ARPA) permit or other BLM special use permit is also required from the appropriate federal land-managing agency for work on federally managed public lands. If there is any state involvement (i.e., SHPO review or NSM curation) in a project on private property, then we request that you obtain a Nevada Antiquities permit.

State antiquities permits are issued for a period of one year, and permit renewal requires a new application and current, curriculum vitae or updates to vitae on file. “Person in charge” is the principal investigator, and “Field Director” is responsible for the day-to-day conduct of fieldwork. Multiple individuals can be listed in either category. Qualifications for “Person in charge” follow the Secretary of the Interiors Standards and Guidelines for Archaeology. “Field Directors” must demonstrate experience as a project field director overseeing day to day project supervision of crew chiefs and field crews. We do not permit crew chiefs. Registration in the Register of Professional Archaeologists (RPA) is encouraged.

Qualifications **must** reflect experience in Great Basin archaeology. These can be highlighted on the vita or in an attachment to facilitate review and approval. Persons lacking Great Basin archaeological experience will not qualify for a Nevada antiquities permit. Experience must also reflect competence in sub-regions or counties where an individual is planning to work.

The museum responds to applications within 30-days.
